RE: NOTICE OF INTENTION TO GAZETTE ALL LICENSED SUPPLIES MANAGEMENT PRACTITIONERS AS AT 30TH JUNE 2023 IN LINE WITH THE SUPPLIES PRACTITIONERS’ MANAGEMENT ACT (2007) AND REGISTRATION & LICENSING REGULATIONS (2015)

Kenya Institute of Supplies Management (KISM) is established under Section 3(1) of the Supplies Practitioners Management Act, 2007 (the SPMA) to, amongst other functions, register, license all Supplies Practitioners in Kenya and to regulate their practice.

A Notice of intention to publish in the Kenya Gazette all licensed Supplies Management Practitioners is hereby issued. This is in accordance with the Supplies Practitioners Management Act sections 16, 20 and 21 and attendant Regulation 27(1) & (2). The gazette notice shall be prima facie evidence that persons named therein are duly licensed based on their renewals for the year 2023 and therefore authorized to practice under the Laws of the Republic of Kenya.

The notice is for all Supplies Practitioners (including Supply Chain Management officers, Procurement officers, Managers, Procurement Directors, Warehousing/Stores officers, Logistics officers, Lecturers, SCM-Investigators and Consultants) in the Republic of Kenya. The gazette notice will include the list of all licensed practitioners by KISM as at 30th June 2023.

Feedback and member concerns should be addressed to the the Institute through membership@kism.or.ke by 15th June, 2023.

A full list of all duly licensed members shall also be posted on the Institute’s website, www.kism.or.ke . This therefore requires all Supplies Practitioners in the Republic of Kenya, to take note of the likely offences under Section 31 and 32 and indicative sanctions for violations of same.

We encourage all Supply Chain Practitioners to fully familiarize with the detailed requirements of the law, and to fully and urgently comply by registering or renewing their membership and licenses with KISM to avoid undue penalization.
